



MBTA ADVISORY BOARD
MEETING MINUTES

May 24, 2022
10:00 AM – 11:00 AM

- A. **Call to Order:** Mayor Thomas P. Koch, Chair called the meeting to order at 10:02 AM via zoom.
- B. **April 26, 2022 Meeting Minutes:** The minutes were presented. Dan Salvucci (Whitman) made a motion to approve the minutes as presented. Rich Prone (Duxbury) seconded this motion, which was approved unanimously.
- C. **FY23 MBTA Operating Budget Oversight Report:** The Chair requested a motion to take item E. Report of the Operating Budget Oversight Committee on the agenda out of order. Dan Salvucci made a motion to this affect. Todd Kirrane (Brookline) seconded this motion, which carried unanimously. Brian Kane (Executive Director) presented the report on behalf of the Operating Budget Oversight Committee. The Chair facilitated a question-and-answer session between members/designees, committee members, and the Executive Director. Following discussion, Rob Scherer (Ashland) moved to accept the report and make it an official report of the body. Dan Salvucci seconded this motion, which was approved unanimously
- D. **Executive Director's report:** Brian Kane (Executive Director) presented the report on recent activities and efforts by Advisory Board staff on behalf of members.



- E. **Commuter Rail Committee Report:** Rob Scherer, Committee Chair gave the report, which included a summary of recent meetings and committee activities. He also reported that the committee recommends no action on the Duxbury resolution for special baseball trains to travel from Lansdown Station to Kingston Station following the conclusion of Red Sox baseball trains.
- F. **Bus Network Redesign:** Brian Kane announced that the Advisory Board is required to take action on the MBTA's proposed Bus Network Redesign as it constitutes a major service change. He recommended that this matter be referred to the Rapid Transit Committee for its consideration, and charge it to report back to the full board with a recommendation for action. Brad Rawson (Somerville) made a motion to this effect. Bruce Leicher (Harvard) seconded this motion, which was approved unanimously.
- G. **Upcoming meetings:** B. Kane announced the dates of upcoming meetings.
- H. **Announcements, old/new business:** There were none
- I. **Adjourn:** Colette Aufranc (Wellesley) offered a motion to adjourn. Dan Salvucci seconded this motion which was approved unanimously. The Chair adjourned the meeting at 10:42 AM.
